3. **Aims and Objects:**

**RULES AND REGULATIONS OF THE SOCIETY.**

- (1) NAME OF THE SOCIETY : **SARASWATHI EDUCATIONAL ACADEMY**
- (2) OFFICE ADDRESS : D.No: 8-143/1, Raithupeta, 8, Nandigama, Krishna Dt
- (3) MEMBERSHIP:
- (a) Any person after completion of 18 Years of age and abides by all the Aims and objectives and the Rules & Regulations of the Society is eligible for Membership.
- (b) Admission fee of Rs. 50/- and life membership is Rs. 5000/- or yearly subscription is Rs. 500/-
- (c) Any member who commits defaults without paying the Monthly subscription or any other amount due by him to the Society any account with in 3 (Three) months from due date, automatically ceases to be a member after the expiry of the said three months.
- (d) Any person so ceasing to be member shall be re-considered as a new member at any time of the payment of the usual entrance fee and other dues, if any.
- (4) GENERAL BODY & ITS FUNCTIONS :
- (a) The property of the Society shall vest in the General Body consisting of all the members;
- (b) General Body shall meet at least twice in a year in the months of June and December as decided by the executive body.
- (c) Quorum of General Body is 1/3<sup>rd</sup> of the Total members on roll.
- (d) All question arising at the meeting shall be decided by majority of votes of members attended such meeting.
- (e) The Agenda of the General Body meeting shall prepared by the Secretary.
- (f) The notice of general Body meeting of Society shall be served to all members not less than 10 days clear prior to the date of meeting. Non-receipt of such notice by any members shall not invalidate proceedings of such meeting.
- (g) To pass the Budget for the ensuing year and approve the expenditure statement of previous year.
- (h) To approve the report of the activities of the Society.
- (i) To elect the Executive committee etc.,
- (j) The General Body appoints Auditor for the Audit of Accounts of the Society n and for Certification of Balance sheet and other Annual Accounts.

(5) EXECUTIVE COMMITTEE :

- (a) Exact number of the Executive Committee (7) Seven i.e., One President, One Vice - President, One Secretary, One Joint secretary , One Treasurer and Two Executive Members.
- (b) Executive members' term is Five years.
- (c) The Quorum of the Executive Committee meeting shall be 2/3<sup>rd</sup>.
- (d) Any vacancy, occurring in the Executive Committee shall be filled in by the Executive Committee, which shall be convened within one month for the purpose.
- (e) Any member of the Executive Committee, who fails to attend three consecutive ordinary meetings of the Executive Committee after personal advice or notice of the Meetings, shall cease to be members of the Executive Committee. The vacancy caused thereby shall be filled-up in the usual manner by the Executive Committee.
- (f) Executive Committee at the usual most shall meet quarterly.
- (g) There shall be 5 days clear notice for meeting of the Executive Committee except in case of emergency.
- (h) The Executive Committee shall have the power to received donations or Government grants may be accepted and get audited.
- (i) It shall prescribe procedures and guide the office bearers in their functions. The decisions of the Executive shall be binding on the office bearers.

(3) SECRETARY :

(6) EXECUTIVE MEMBERS :


They will attend to the affairs of the Society as per the directions of the Executive Committee. They will attend to other work relating to the Society and strive for the development of the Society.
